The Cumberland County Bar Association partners with MidPenn Legal Services and The Dickinson School of Law Community Law Clinic to provide equal access to justice for low-income persons.

To qualify for free legal services you need to:

1. Be a resident of Cumberland County, PA
2. Have a concern that is eligible. The following legal issues may be eligible for free legal services:

*Bankruptcy/ Creditors
Child Support
Custody
Disability/ Social Security
Divorce
Expungement
Pardons
Foreclosure
Landlord-Tenant
Protection From Abuse
Unemployment Compensation
Wills/ Estates/ Powers of Attorney
Misc. other cases

To apply for services and to see if you meet the federal poverty guidelines.

If you qualify under the federal poverty guidelines you will be advised what legal service provider office can assist you.

If you do not qualify for free assistance:

The first 30 minutes of a consultation with a local attorney is \$25.00.

Within that time the lawyer will provide you legal advice and discuss with you the costs of retaining them as your attorney.
